Information on the processing of personal data pursuant to articles 13-14 EU Reg. 2016/679

Interested parties: **customers/suppliers**

Tau Metalli SRL as data controller of your personal data, pursuant to and for the purposes of the EU Reg. 2016/679 hereinafter 'GDPR', hereby informs you that the aforementioned legislation provides for the protection of data subjects with regard to the processing of personal data and that such treatment will be based on the principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Your personal data will be processed in accordance with the legislative provisions of the aforementioned legislation and the confidentiality obligations therein.

Purpose and legal basis of the processing: in particular, your data will be processed for the following purposes related to the implementation of related obligations:

- to legislative or contractual obligations: tax and accounting statutory obligations;
- customer management.

Processing methods: your personal data may be processed in the following ways:

- outsourcing of processing operations;
- treatment by electronic computers;
- manual processing by means of paper archives.

Each treatment takes place in compliance with the methods referred to in articles 6, 32 of the GDPR and through the adoption of the appropriate security measures provided.

Your data will be processed only by personnel expressly authorized by the Data Controller and, in particular, by the following categories of employees:

Communication: your data may be communicated to external subjects for a correct management of the relationship and in particular to the following categories of recipients including all duly appointed Data Processors:

- banks and credit institutions;
- consultants and freelancers, also in associated form.

Disclosure: your personal data will not be disclosed in any way.

Retention period: we point out that, in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to art. 5 of the GDPR, the retention period of your personal data is:

- established for a period of time not exceeding the achievement of the purposes for which they are collected and processed for execution and fulfillment contractual purposes;
- established for a period of time not exceeding the performance of the services provided;
- established for a period of time not exceeding the achievement of the purposes for which they are collected and processed and in compliance with the mandatory deadlines prescribed by law.

You have the right to obtain from the owner the cancellation (right to be forgotten), the limitation, the updating, the rectification, the portability, the opposition to the processing of personal data concerning you, as well as in general you can exercise all the rights provided by art. 15, 16, 17, 18, 19, 20, 21, 22 of the GDPR.

EU Reg. 2016/679: Articles 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the interested party

1. The interested party has the right to obtain confirmation of the existence or not of personal data concerning him, even if not yet registered, their communication in an intelligible form and the possibility of making a complaint with the Control Authority.

2. The interested party has the right to be informed:

- a. the origin of personal data;

- b. the purposes and methods of treatment;
 - c. the logic applied in case of treatment carried out with the aid of electronic instruments;
 - d. the identity of the owner, manager and the representative appointed pursuant to article 5, paragraph 2; is. of the subjects or categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the territory of the State, managers or agents.
3. The interested party has the right to obtain:
- a. updating, rectification or, when interested, integration of data;
 - b. the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those which need not be conservation in relation to the purposes for which the data were collected or subsequently processed;
 - c. certification that the operations referred to in letters a) and b) have been brought to the attention, also with regard to their content, of those to which data have been communicated or disseminated, except in the case where this fulfillment proves impossible or involves the use of means manifestly disproportionate to the protected right;
 - d. data portability.
4. The interested party has the right to object, in whole or in part:
- a. for legitimate reasons, to the processing of personal data concerning him, even if pertinent to the purpose of the collection;
 - b. to the processing of personal data concerning him for the purpose of sending advertising materials or direct selling or for carrying out research of
 - c. market or commercial communication.
